




## FLASH CONSUMER CONFIDENCE INDICATOR FOR EU AND EURO AREA

In July 2022, DG ECFIN's flash estimate<sup>1</sup> of the consumer confidence indicator<sup>2</sup> dropped by another 3.0 points in the EU and by 3.2 points in the euro area (EA).<sup>3</sup> At -27.3 (EU) and -27.0 (EA) points, consumer confidence scored below its previous minimum reached at the beginning of the COVID-19 crisis, hitting the lowest level on record.

<sup>1</sup> This month's Flash CCI for the EU aggregate is computed on the basis of consumer survey data from 26 EU countries, covering 98% of the total private final consumption expenditure. For the euro-area indicator, all 19 Member States are included in the total.

<sup>2</sup> The consumer confidence indicator builds on replies to selected questions addressed to consumers according to the Joint Harmonised EU Programme of Business and Consumer Surveys. ### Information

**Data collection period:** July 1-19

**Release policy of the Consumer Confidence Indicator (CCI):** Every month, the Directorate-General Economic and Financial Affairs (DG ECFIN) of the European Commission releases the flash CCI for the EU and euro-area aggregates, using the data available on the cut-off date. The final Consumer Survey results are then published as part of the full Business and Consumer Survey release at the end of the month.

The Joint Harmonised EU Programme of Business and Consumer Surveys is managed by DG ECFIN's Unit Economic situation, forecasts, business and consumer surveys (A3), Sector Business and consumer surveys and short-term forecast.
